GENERAL RULES AND PROCEDURES **CITY OF PARKLAND CITY COMMISSION MEETINGS**

WHO MAY SPEAK

Meetings of the City Commission are open to the public. They are not however, public forums. Any resident who wishes to address the Commission, on any subject within the scope of the Commission's authority, may do so providing it is accomplished in an orderly manner and in accordance with any procedures outlined below:

A. SPEAKING ON ITEMS ON THE AGENDA

1. **CONSENT AGENDA ITEMS:** These are items which the Commission does not need to discuss individually and which are voted on as a group. Any Commission member who wishes to discuss any individual item on the consent agenda may request the Mayor to pull such items from the consent agenda. These items pulled will be discussed and voted upon individually.
2. **REGULAR AGENDA ITEMS:** These are items which the Commission will discuss individually in the order listed on the agenda. After the Commission has discussed an item on the agenda, the Mayor will close Commission discussion and may inquire as to whether any citizen wishes to be heard on the matter.

B. SPEAKING ON SUBJECTS NOT ON THE AGENDA

Any resident may address the Commission on any item not on the agenda during public input.

ADDRESSING THE CITY COMMISSION, MANNER, TIME

Individuals will be limited to three minutes speaking time. All comments or questions of the public are to be directed to the Mayor as presiding officer only. There shall be no cross conversations or questions of any other persons. Citizens wishing to be heard shall raise their hands until acknowledged by the Mayor. Once acknowledged, those citizens shall come forward and state their name and address. Anyone wishing to speak a second time on the same subject must receive permission from the Mayor.

DECORUM

In order to adjourn a City Commission meeting, it must be voted on by the members of the Commission.

- C. **Resolution No. 2023-058: FY 2024 Stormwater Management Assessment**
A Resolution of the City of Parkland, Florida, relating to the provision of stormwater management services provided by the City's stormwater utility; providing authority and definitions; confirming the initial assessment resolution; imposing stormwater service assessments against developed property located within the stormwater service areas for the fiscal year beginning October 1, 2023; approving the rate of assessment; approving the assessment roll; and providing an effective date.
- D. **Ordinance No. 2023-013: Adopting the FY 2024 Millage Rate (First Reading)**
An Ordinance of the City Commission of the City of Parkland, Florida, adopting the millage rate to be levied for the Fiscal Year beginning October 1, 2023 and ending September 30, 2024; stating the percentage change by which the millage rate exceeds the rolled-back rate as computed pursuant to Section 200.065, Florida Statutes; providing for conflicts, severability, and providing for an effective date.
- E. **Ordinance No. 2023-014: Adopting the FY 2024 Budget (First Reading)**
An Ordinance of the City Commission of the City of Parkland, Florida, adopting a budget for the Fiscal Year beginning October 1, 2023 and ending September 30, 2024; providing for conflicts, severability, and providing for an effective date.
- F. **Ordinance 2023-011: Redistricting (First Reading)**
An Ordinance of the City Commission of the City of Parkland, Florida, redistricting the City into four City Commission districts, drawn as nearly as is

practicable on an equal population basis by contiguous boundaries, for the November 2024 and November 2026 municipal elections, pursuant to City Charter Section 3.02; providing for severability, conflicts and an effective date.

- G. **Resolution 2023-054: Exotic Vegetation Removal and Maintenance at Doris Davis Forman Preserve**
A Resolution of the City Commission of the City of Parkland, Florida, approving EDJ Tree Service, Inc. for exotic invasive vegetation removal and maintenance services at Doris Davis Forman Preserve for Fiscal Year 2024 in the amount not to exceed \$138,987; providing for execution; providing for an effective date.
- H. **Resolution 2023-055: Work Authorization for PH Consulting Services, Inc.**
A Resolution of the City Commission of the City of Parkland, Florida, approving a work authorization with PH Consulting Services, Inc. for professional landscape plans examiner and inspection related services for Fiscal Year 2024 in an amount not to exceed \$180,000; providing for execution; providing for an effective date.
